Client overview | Powering a public utility with confident control



Snohomish County Public Utility District (SnoPUD) delivers essential services to a large, diverse community in Washington State. Alongside reliable power, SnoPUD manages mission-critical information spanning assets, maintenance, projects, and regulatory records. As usage of OpenText™ Content Management expanded - and with a move toward OT Cloud - SnoPUD needed precise access control and trustworthy, large-scale data migration.



Governance challenges in a growing environment

SnoPUD's environment grants access in three different ways - via HR provisioning (Employee Central), SAP roles (synced to AD groups), and business-managed groups. That complexity made it hard to answer audit questions such as who has access now, who had access before, and how access was granted.

At the same time, SnoPUD needed to lift large volumes of content from on-prem shares into Content Management without breaking metadata crucial for lifecycle, retention, e-discovery, and compliance.





For migrations and ongoing updates, SnoPUD used Bulk Data Manager to move at scale while protecting meaning:



Pre-load Excel review to clean inputs (e.g., strip thumbnails/system files) before import.

Merge and manipulate spreadsheets to shape the perfect import set.

Detailed logs validate every transfer, enabling proof and rapid remediation.

Cloud-friendly footprint (API-driven with a small service), ideal for OT Cloud.
