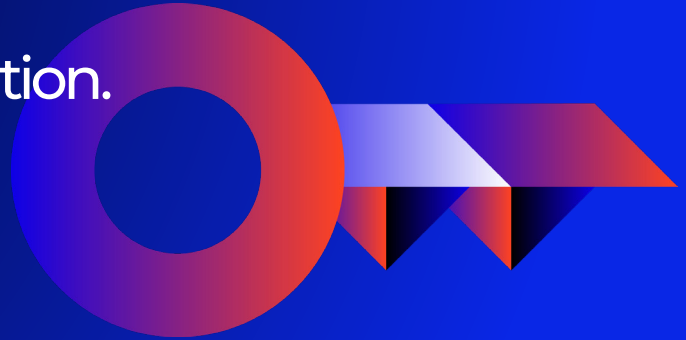

**Enabling safe, bulk updates - including rollback - to fix to-template or custom permissions with confidence.**

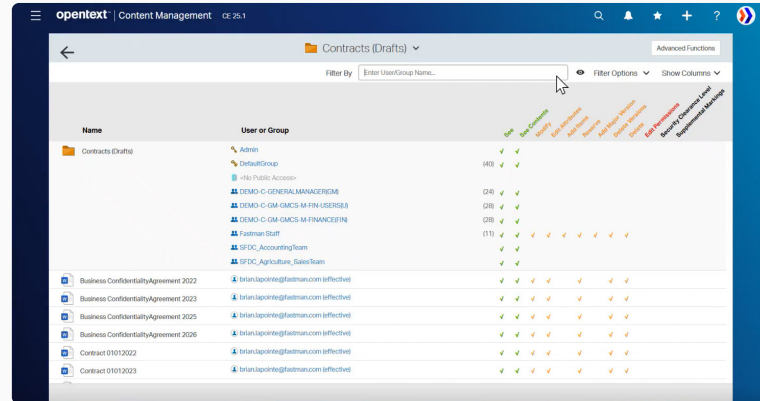
